GUIDELINES: THIS IS A JURIED SHOW Pictures, (no more than 3) are required of your complete product with

your name on back. NO PETS ARE ALLOWED.

BOOTH Booth assignments will be made by the Craft Show Management.

LIABILITY & Each exhibitor will be required to provide a Certificate of Insurance, (proof of insurance) or sign

and send back attached waiver.

INSURANCE: Your Certificate of Insurance DOES NOT carry over year to year. EVERYONE must provide

a new certificate each year.

This Insurance Certificate must be on file in our office prior to <u>January 30, 2026</u>. This can be done easily by contacting your business insurance company or you homeowners' insurance company. (There may be a very minimal fee). If you have questions regarding

LOADING/ UNLOADING: West side doors of National Guard Armory 747 7th St SE Valley City, ND 58072(across the street from the East entrance of the NDWS Building).

ELECTRICAL HOOK UPS: Electricity is available for an additional fee of \$25. You must provide your own extension cord.
