DRUG TESTING WAIVER: The North Dakota Winter Show and contest officials reserve the right to have a licensed veterinarian test your horses for foreign substances. If the test is negative, the person requesting the test will pay the fee. **If test comes back positive, there will be a \$1000 fine, and the participant and their horses will be barred from participating at the North Dakota Winter Show for the following year's show.**
