General Information/Requirements:

- Mutton Busting will be held during each of the three PRCA rodeo performances at the North Dakota Winter Show, with the rodeos scheduled as follows: Friday March 12, 7 pm and Saturday March 13, 2 pm & 7 pm.
- To enter, kids must be ages 4-7 and weigh 55 pounds or less. A protective vest and helmet will be provided.
- No entry fee is required, but tickets must be purchased for the respective rodeo performance. Tickets for ages 2 and under are free, ages 3-12 are \$12, or for Saturday afternoon's performance only, FREE with the purchase of an adult ticket per child. Tickets for ages 11 and up are \$20. Prizes will be awarded to the first place contestants in each competition.
- Each mutton busting competition will be limited to only 8 contestants, so get your forms in early!
